TB Global Technologies Ltd. Received order for loading arm for LNG shipment at major liquefied natural gas project in Qatar

TB Global Technologies Ltd. (Kyobashi Edo Grand 28F, 2-2-1 Kyobashi Chuoku Tokyo, President; Laurent Poidevin), one of the group companies of Tokyo Boeki Group, received an order from Samsung C&T Corporation (Head Office: Seoul Korea), for the Qatar Gas North Field Expansion (NFE) Project (the "Project").

This project is a very large-scale project to produce and export 32 million t/y of LNG from the North Field gas field in Qatar, the largest single gas field in the world, and our LA will be installed sequentially at the Ras Laffan LNG export port in Qatar, which has the world's largest shipment volume. Through this project, Qatar plans to increase its LNG production from 77 million tons to 110 million tons per year. The project will also enable the production of LNG with more than 25% less greenhouse gas emissions than existing LNG plants, and through our LA, cleaner LNG will be shipped not only to Japan but also to the rest of the world.

We are very proud to have been selected as the LA supplier for this strategic project, which is a testament to our more than 50 years of experience in LNG transfers, as well as to our customers' recognition of our outstanding quality and service record in Qatar.

Through the development, manufacture, sales, and maintenance services of energy-related machinery, centering on its mainstay loading arms, TB Global Technologies aims to contribute to the development of the global energy society, create abundant value as a technology partner of its customers, and contribute to the lives and society of countries around the world.
